**PUBLIC SERVICE ANNOUNCEMENT FROM DZIL YIJIIN JUDICIAL DISTRICT**

In accordance with Navajo Nation Supreme Court Administrative Order 26-2020, the Dził Yijiin Judicial Court is closed to the public, and will be conducting essential court operations only. All services will be subject to temporary mitigation measures designed to protect our patrons and team members to the greatest extent possible. Please note that many court services can be handled online, by phone or by mail. The Court's contact information is noted below.

Physical access to the Dził Yijiin Judicial Court is currently restricted. The public will call in for telephonic hearings. If you are unsure about the status of a case or have difficulty accessing the online resources, please contact our court via email at [ndycourt@navajo-nsn.gov](mailto:ndycourt@navajo-nsn.gov).

The Dził Yijiin Judicial District has rescheduled all out-of-custody criminal and civil traffic matters and is actively monitoring its calendar to determine the need to further continue cases. Notices of rescheduled cases continue to be mailed to last known addresses on file.

Phones are consistently monitored and messages are routed in the order they are received; however, email will be the most efficient form of communication for the public's inquiries and filing of pleadings. **Filings** – Filings of pleadings and petitions can be submitted by email, fax or U.S. mail. Filings can also be submitted through the designated drop box located next to the main entrance of the Court.
